A. Developmental Loans:

3. Budget Approvals

As per provision of Sec. 38 of Maharashtra Agricultural Produce Marketing (Development and Regulation) Act - 1963 the MSAMB has approved Main budgets of 288 APMCs during year under report. MSAMB has also approved Supplementary

Budgets of 169 APMC's and Reappropriation Statements of 84 APMC's which were received from APMCs during the year under report.

4. Subsidy for Hamal Bhavan

As per provision of Sec. 39(B) 2 of Maharashtra Agricultural Produce Marketing (Development and Regulation) Act 1963, MSAMB has launched scheme to grant 25% subsidy subject to a maximum of Rs.5.00 Lakh per beneficiary for construction of Hamal Bhavan (Resting Place for Hamals and other similar market functionaries) by Market Committee or Hamal Unions.

5. Subsidy for Shetkari Niwas / Bhavan

As per provision of Sec. 39(B) 2 of Maharashtra Agricultural Produce Marketing (Development and Regulation) Act 1963, MSAMB has launched scheme to grant 25% subsidy subject to a maximum of Rs.5.00 Lakh per beneficiary for construction of Shetkari Niwas / Bhavan (Resting Place for farmers) by Market Committee.

6. Mechanical Grain Cleaning System

MSAMB has a scheme to grant 10% subsidy subject to maximum of Rs. 2.00 Lakh per beneficiary for setting up Mechanical Grain Cleaning System by Market Committee. No subsidy was granted under this scheme, as there was no proposal by any APMC during year under report.

7. Direct purchase of Agricultural produce by Companies in the APMCs

Power delegated as per Sec. 59 of Maharashtra Agricultural Produce Marketing (Development and Regulation) Act 1963, Govt. of Maharashtra has given the permission to I.T.C. Ltd., Cargill India Pvt. Ltd., Megasave Pvt. Ltd., Reliance Fresh Limited, Radhakrushna Foodland Pvt. Ltd., Aaditya Brila, Quadrangle Traading Service Private Ltd, Consumer Trading, Mahindra Shubh-Labh to purchase the Agricultural produce in Maharashtra State. Above Companies can purchase the Agricultural produce directly from the farmers in the operational area of individual APMC And Companies has to follow and conditions given in the permission. Accordingly companies are purchasing Agricultural produce on large scale. The farmers are also getting remunerative prices out of it.
